#### **Public Comment**

Jamie Dubinsky at 128 Chopp Street, Sutersville, had a question regarding the selling of Sewickley Sutersville Sewage Authority to MAWC. How is that going to affect the cost of our sewage and if MAWC buys SSMSA. Does that mean there is room for expansion? Mr. Kerber stated that our goal is to try and keep the cost down. If and when Elizabeth Sewage is moved, according to the DEP, the cost per month to Elizabeth may go up \$30 a month. There is no way that SSMSA can get out of that agreement until the debt is paid. The one thing that is a positive is that if MAWC purchases SSMSA, they will pay off the debt. They are going to invest allot of money into reversing all the lines and pumping it up to MSATS which they are looking at purchasing also, and guaranteeing no rate hike for 5 years. There would be a flat rate to all customers in that authority. This will eliminate allot of the problems with high consumption costs. There are a lot of layers to this. We have had numerous meetings, one a couple Mondays ago and one this Monday with the DEP in Pittsburgh. There is going to be competing offers on the table from PA American and MAWC. What it comes down to is the SSMSA board's decision. They are the ones going to make the decision and recommend to Sewickley Township what the course of action will be. My recommendation would be to talk to the members on that board and express your concerns to them. Hopefully, they will make the best choice of what's best for their customers. Time is of the essence here. There have been other offers, but we can't turn our backs on this one. The concern right now is to stabilize that authority and to make sure customers are not going to be paying outrageous costs down there.

Patty Volpe from General Braddock Road wanted to thank the Township for fixing the pothole and putting up the speed limit signs on General Braddock Road.

Magaret Sensue would like to know if the hearing in May regarding the nuisance issue near her home is open to the public. Attorney Kansler stated that he believes so. Generally, all hearings are open to the public, at least at the Court of Common Pleas.

Mike Aujay is here on the behalf of Sewickley Area Athletic Association. He is wants to know when the completion of the plumbing work will be done so they have water in the concession stand. Mr.Kerber stated that we are hoping for the end of April. We will see about getting you a water buffalo over there. Mr. Aujay stated that we have about 172 kids signed up and we start this Monday. Rita Aujay expressed the concern over the ruts at the ballfields and the dangers of them. Mr. Aujay stated that they had a very successful fundraiser. With the funds we are going to put a new roof on the concession stand, dugout roofs, build a pavilion next to the concession stand, put a new storage pod over by the pony field, purchase a new tractor for field work and add a flag pool with a light.

Lisa Smartnik from SAAA stated that the athletic association brings into the township thousands of people. It would be nice to get the water on over there.

Greg Hazuza asked when Pinewood Road is going to be fixed. Mr. Kerber stated that as soon as we get our McGrogan Road project finished we are going to start on Pinewood Road. Mr. Hazuza stated that there are some major potholes on that road.

## **New / Old Business**

Linda Harvey had a question regarding number 17 on the agenda. She asked if this meeting is for the general public. Attorney Kansler stated that this meeting is for a quorum of the Board of Supervisors to address a property maintenance code. It's going to be a public meeting. It will be advertised in the Tribune Review.

A resident asked if there is a completion time regarding the sewage project in Hutchinson. Mr. Merdian stated that a scheduled completion date for that project is late August. Maybe a little sooner. That includes the pump station and treatment plant. The main work that is being done by Pollard Construction will be done within the next two to four weeks. Of course they need to do restoration afterwards. The resident asked if they are going to pave our roads. Mr. Merdian stated that they are going to just be doing patch work. Mr. Merdian stated that if there are additional funds from the PENNVest loan we can go to go to the county and see if we can get some additional funding to fix the roads. It's no promise, but it is something we are looking into. Tap in notices will probably be going out late July. Everything will need to be inspected and tested for use first and then when we know it's all good to go, tap in notices will be sent out. It might even be early fall before they are sent.

Mike Aujay from SAAA also asked if we could get a new lock and fix the hole in the fence around the old tennis courts. Mr. Kerber stated that we will get the fence fixed and get you a new lock. Mr. Aujay asked about the slide at the playground. Mr. Kerber stated that we have not yet found a replacement. Mr. Merdian stated that we are looking into finding some funding for a new playground. Mr. Aujay stated the old bleachers need removed. We have someone that will come and remove them. The supervisors advised if you have someone come and remove them, have them sign a waiver or release.

Mrs. Dull asked about the weather siren. Mr. Kerber stated that it has been voted on unanimously at a previous meeting to have it tested by Thornton and Acoustics Vibrations. We are going to move forward with the test.

With no further business to come before the Board, Brian Merdian made a motion to adjourn, seconded by Mark Petros. Voting: Voting: Mr. Kerber, Mr. Merdian, Mr. Petros; yes. Motion carried unanimously. Meeting adjourned at 7:35pm.
