### Report from Roadmaster, Joe Kerber

The Road Crew has been out 12 days salting roads. We have used approximately 2600 tons of salt and 1300 tons of anti-skid this year. The road crew spent seven days patching roads. We finished brushing on Balentine Road and started in Hutchinson. We have been busy keeping up with the equipment in the garage. The truck with the broken axle is now up and running. The township has extensive road damage from the heavy rains on February 15<sup>th</sup> and 16<sup>th</sup>. We have crews out every day repairing the roads from these rains. Mr. Fossi asked how Mr. Kerber is coming with his spray permit. Mr. Kerber stated that it is on the agenda to vote for me to take the test.

# Report from Ordinance Officer, Nick Newcaster

All of the following information has taken place since the last Board of Supervisors Meeting on 01/17/18: Sixteen (16) warning letters were mailed, which pertained to JMVs (Junk Motor Vehicles), rubbish, dangerous structures, and junk yard violations. Some complaints have been resolved without having to mail letters, such as burning and parking. Two complaints, one for JMVs (formerly a tagged vehicle) and the other for JMVs and dangerous structures, were filed before MDJ CHRISTNER. One tagged vehicle in Lowber has been voluntarily moved. Mrs. Schork stated that we are seeking volunteers to help with recreation activities. She stated that you do need your clearances.

Brian Merdian made a motion, seconded by Mark Petros to approve the minutes of the Sewickley Township Board of Supervisors Reorganization Meeting held on January 2, 2018 as reviewed. Voting: Mr. Merdian, Mr. Petros, Mr. Kerber; yes. Motion carried unanimously.

#### **Public Comment**

Terry Stafford wanted to know when we are going to get his issue solved. I can't rent the house out now because it's a liability. Mr. Kerber stated that it is on the list to be down. Mr. Stafford stated that it has been three years now.

Carol Keller form Judy Drive is concerned about blinking lights at H.W. Good Elementary. She stated that she spoke to Dr. Sardon and the Board of Supervisors is to meet with her along with Penn Dot. Mr. Merdian stated that Gibson Thomas went ahead with the design work and they are going to be meeting with Penn Dot to continue the process. As part of the discussions that have been going on, at the last school board meeting they made a determination that they will support and assist at some degree for blinking lights at the Elementary school, but they are not interested in doing anything in front of the High School. We are still going to proceed with the engineering work to be submitted to Penn Dot to get the permit. Mr. Merdian said they reached out to Justin Walsh and Kim Ward to see if some kind of funding is available. Mrs. Keller stated that she spoke to Dr. Sardon and the cost of the lights would be \$ 20,000 apiece. The township would be responsible for paying the light bill. Mr. Merdian stated yes, that is correct. Ms. Keller stated that she heard the school will pay the \$ 20,000 but they need to see if they can get funding.

Mr. Volpe stated that he is continuing to get 911 phone calls for road issues. He called up here to complain and he is still getting them. I wish you would get it straightened out at the 911 center. Mr. Kerber and Erika Horvat stated that they will call them and we will reach out to our Emergency Management to make a phone call to them also. Mr. Volpe also stated that it is unfair that we got our taxes raised but don't get the service of a street light. Mr. Merdian went on to explain that we are looking into adding more street lights to the township. Mr. Volpe also asked if we can get a speed limit sign on General Braddock Road.

Alan Fossi from 171 Wilps Drive had an opportunity to look at the auditor's report from 2018. It states on here that the auditors were having a little trouble getting some information on your salary to determine your salary for this year, which was approximately \$87,000 last year. I suspect that the trouble would be made more from the auditors than the office personal. The other concern I have in the report is that the auditors stated that the Board of Supervisors received a meeting pay of \$3,000.00 and according to the township code, it should have been \$2500.00. So my concern is, we have three auditors here that do not know how much we earn. We received \$2,500.00. This is a major concern. Mr. Kerber stated that we are going to address that tonight under new/old business.

Jeff Thoma asked who is in charge of the pipe that comes out of the school and runs down the side of Reed Lane. Its saturating the roadway and causing issues with his foundation at his house. The other concern I have is when it rains water gushes down the school parking lot, shoots across the road and runs down into my property. Mr. Thoma stated that there are no catch basins in that area. When the sewage came through things never got graded properly and its created a pond. Attorney Kansler suggested that if the water issue is caused because of the Sewage Authority then you need to contact the Sewage Authority. You can also contact the school in regards to the water coming off of their parking lot. The water running is also causing an issue with a sewer line. Mr. Merdian stated we will be out to fix the sewer line. Mr. Thoma asked if this is the schools issue or the townships. Mr. Kerber stated that this is a state road. The excessive water is being caused by the school parking lot. Mr. Thoma suggested putting in some pipe and catch basins. Mr. Kerber stated that we will look into it. Mr. Merdian stated that from a sewage authority point we will look into it also.

Austin Weinman from Penn Tex Ventures is here to represent the Dollar Store being built in Herminie. He was trying to get some clarification on what the next steps will be. Will we be on the March's Supervisors meeting agenda? Mr. Kerber stated it will be if it is passed through Planning. Mr. Weinman also asked if we could get some of our permits before the plans are officially approved. Mr. Weinman stated that the plans were delivered yesterday. Attorney Kansler stated he would need to check the Earth Disturbance code. There is a section that does address permits.
