Report from Roadmaster, Joe Kerber

We have been out repairing Apples Mill Road and Derr Road due to the major washouts from the heavy rains. I had the crew out for four days patching. We finished rolling the ball fields. We have been working at the park for six days repairing the driveway and cutting down trees. We have been helping to get the pool ready for the new liner. Mr. Kerber stated that we are now concentrating on the pool. We have allot of culvert repairs to do then we will move to there. We did get some money from the logging company for some of the damage. I would like to wait till they are out of there. A resident tasked about another company doing work there. Mr. Kerber stated that is the water authority and we do have an agreement with them.

Public Comment

Terry Stafford had a concern with the property at 523 Church Street Mr. Kerber stated that we did get the catch basin fixed. There is another pipe there and we are trying to figure out where it comes from. Mr. Kerber asked Mr. Stafford if he knew if the pipe still carries water. Mr. Stafford said if it rains heavy enough. Mr. Kerber stated it is on the list to get fixed. Mr. Stafford stated that he cannot rent the place out like this. It's been three years now. The right side of the road needs stone also, it's washed out bad. Mr. Stafford asked why PennDot is out there. Mr. Kerber stated that they are going to fix the bridge next year.

John Seanor asked about Tomatko Road. He wanted to know if we are going to put weight limit signs up. Mr. Kerber stated that we are. Mr. Seanor wanted to know how we can go about getting a street light. Mr. Merdian stated that we are looking into. We will be dealing with it very soon.

Greg Hazuza expressed his concern with Pinewood Road. This road has not had any attention for many years. I understand there is drainage and shoulder work that needs done. If you do a little at a time it will get done.

Patty Volpe had a concern with the area in Herminie where the main street is, the intersection at Sewickley Ave. It is so bad. I know it is a state road, but can we make a call to the state and county to get these roads fixed. Mr. Kerber stated that he has called regarding this situation, the road near the Old Catholic Church and Lowber Road. I also contacted our PennDot representative Rick Skovensky.

Sandy Dull asked to be updated on the fire whistle. Mr. Kerber stated that we have to get an agreement with Herminie VFD to set the whistle off for the entire cycle. We know that we might get a hard time from them so we want to have a backup plan. Mrs. Dull stated that from her understanding it is the same whistle as Rillton VFD. Mrs. Dull stated it has been three years now. Mr. Kerber said we have been talking about this. Mrs. Dull stated that she would like for someone to stand in her yard when the whistle goes off.

Linda Harvey expressed her concerns regarding the Ordinance for the smoke detectors and Carbon Monoxide detectors. There wasn't much discussed about these. It was advertised in the paper and was very clear what was going to be done. At the meeting though, there was not any discussion about the Ordinance. Tonight is the meeting that everyone is to come and hear what is going on. Attorney Kansler stated it is on the agenda to be approved. Mrs. Harvey stated that it turns out this Ordinance is much more involved that what has been discussed. The second item on the agenda that I would like to express my concerns over is the motion to advertise a special meeting to discuss a property maintenance code. There was no discussion here and no information was given on this. It was advertised in the paper April 28th and the meeting was scheduled for April 30th. I came to that meeting and there was a lot of information in that meeting. Janet gives her report and Joe gives his report, but nothing is ever discussed by the Township Supervisors. The very next day on Facebook there was in detail what is going on in the Township. I am appalled that I have to go to Facebook to see what is going on in the Township. There were some people making comments on Facebook and if you don't like what is going on then you are shut down. Mr. Merdian stated that you are allowed to ask questions about anything that is on the agenda, have you ever been denied the right to ask a question. Mrs. Harvey stated that we should not be looking to get information on Facebook where we can't ask questions.
