General Public Comment

Norm Vinsick stated his issues with 110 Limerick Road. Pictures were presented to the Supervisors.

John Seanor stated about his neighbor's green pool, 949 Yukon Road. He hasn't received an update from the Ordinance Officer.

Mark Ghion issued a statement voicing concerns with the Lowber Fire Company. Specifically, their request to prevent the closest fire companies to respond to emergency situations. A 21-page petition was presented with signatures from Sewickley Township residents living in the Sutersville Hill, Gratztown, and Scott Haven areas, including the boundaries of Cool Springs and Van Kirk Roads, asking to immediately and permanently recognize the Sutersville Fire Company as their primary emergency service provider in Sewickley Township with the same provisions outlined in the previous 2017 agreement, but with no stipulation for reversal.

Linda Harvey stated that this needs to be looked at objectively. We're looking at all fire services and how best we can meet the needs of the people in our community.

Rick Critchfield asked why a Township Manager was hired when the Supervisors should be making the decisions. Mr. Petros responded that the Supervisors do make the decisions. Mr. Merdian stated that with municipal government, there is a lot more going on than just in the meetings. There are new rules and regulations that need to be followed. There are codes and documents that have to be updated on a regular basis. Two of the Supervisors here have full time jobs, and one is retired. The prudent thing to do is have someone here constantly to stay on top of all those things. Mr. Henderson is the source to gather all the information we need to make the necessary decisions.

Tyler Varney asked about the evaluations/background checks of the fire departments that were done last year. Mr. Henderson stated that the departments turned in required documents to the Township.

Dan Landini, Jr. read a statement regarding public safety and municipal government. He also quoted the Second Class Township Code, Sections 1801 and 1803 regarding Board of Supervisors and fire companies. He gave mileage and times from each fire department to his home with Sutersville VFC being the closest. We need all the help we can get when there is an emergency. Why limit who can respond?

Meri Beth Wees thanked the Supervisors for not selling the building tonight. It is very uplifting for Emergency Management. Regarding the fire departments, she believes all the fire chiefs need to sit down and talk this out.

Mark Petros made a motion, seconded by Brian Merdian, to convene into Executive Session. Voting: Mrs. Harvey, Mr. Petros, Mr. Merdian; yes. Time is 8:00pm.

Regular Meeting reconvened at 8:13pm.

Solicitor Hamilton stated that he advised the Supervisors that they are not empowered to make any decisions on items that have not been previously publicized as an agenda item. The concerns expressed this evening will be considered not only by the Supervisors, but also our consultant and County 911. There have been no changes in Lowber's call out sheet. Sutersville is still on their call out list.

New / Old Business

Reminder that we are still looking for applicants to fill our Recreation Director and Recreation Maintenance positions.

The Township Building will be closed on Thursday, November 25, 2021 and Friday, November 26, 2021.

The 21st Annual Sewickley Township Light Up Night is Saturday, December 4, 2021 with the parade at 4:30pm. Line up is at 3:30pm at the Herminie VFW parking lot.
