Report from Public Works Director, Tom Mignogna

The daily sanitizing and disinfecting are still being done daily. Our Safety Toolbox meeting this month was on Severe Weather Safety. In the past month, we finished the berm work along Balentine Road, Morris Road, Kalamazoo Road, Creek Road, Dick Station Road (as far as we could until the guard railing is replaced), and a part of Firehall Road that was washed out. The spreader boxes have been put on the trucks for winter maintenance and the fleet has been out on a dry run to work out any issues we may have. The EMA generator has been serviced this month. It was used this past weekend when we had the high wind weather event. The Christmas lights were gone over and put up on Sewickley Avenue in Herminie on November 6th. We had 43 PA One Call requests for us to go out and mark our stormwater drains and pipes from other utilities and private contractors. We had a couple of high wind weather events the past two weeks that kept us busy cleaning up trees, limbs, and other debris along with clearing our catch basin grates. The pothole list never seems to end. We are working on that list when permitted. And the signage is still an ongoing project.
